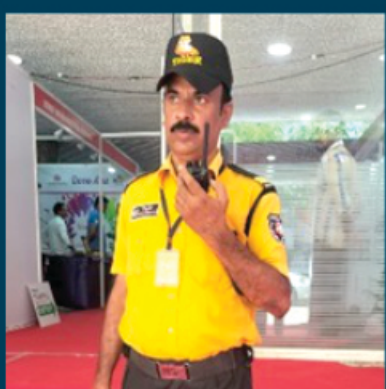

TERMS & CONDITIONS

- ♦ Attendance of the security guards to be submitted to the Field Officer by 25th of every month.
- ♦ Payment should be cleared on (or) before 4th of every month.
- ♦ EPF, ESI challans will be submitted after one month.
- ♦ Feed back proforma has to be completed and has to be handed over to the field officer every month along with attendance.
- ♦ The contract may be terminated by either party after giving one month notice.
- ♦ The contract has to be signed for not less than one year.
- ♦ The company should pay preparatory charges Rs. 1,500 while signing the contract.
- ♦ The company should pay the service charges either by cash (or) cheque.
- ♦ The security guards shall be employed for 12 hours a day. In any case it cannot be exceeded.
- ♦ The security guard should be allowed to sit for 10 minutes every after one hour if it is a standing duty.
- ♦ In case of Mis-behaviour, absent without leave, drunken state, indiscipline by the security guard agency has to be informed and in any case the company should not deal them directly.
- ♦ The security guard should be provided with shelter, table, chair, water and rest room facility etc.
- ♦ Employing our agency security guards as own company staff is a legal offence and punishable by law. Recovery amount will be levied upon legally.
- ♦ Security guards should be provided with a phone, staff designation, important contact numbers whom to contact in emergency etc.
- ♦ First aid and Fire points familiarisation to be given by the company.
- ♦ If more than one security post exists then man power has to be rotated.
- ♦ Security guard has to be treated in a friendly manner.
- ♦ Security guard should not be employed in other office duties.
- ♦ Abuses, man handling (or) degrading of security guard in any manner is strictly prohibited.
- ♦ All the above terms and conditions are not exhaustive it is subject to change according to circumstances by our agency.
- ♦ Security guard should be given a day off after 15 days duty and off duty is also payable.
- ♦ Deployment will be done after 15 days from the date of signing work order.
